Important – please read!

SAFETY, COLLARS & LEASHES: Flexi/retractable leads are ONLY permitted during a search. All dogs must be on a 6' or shorter leash when not participating in a search. Dogs MUST be switched over to a 6' length or shorter leash when outside of the search area. Choke chains, prong collars or halti/head collars are NOT permitted during searches. Leashes of any length may be used while the dog is participating in a search. EVERY dog MUST maintain a minimum of 6' distance from all other dogs at ALL TIMES.

AWARDS: Ribbons will not be mailed.

- A qualifying ribbon will be given at the end of your run.
- 1st-4th place per class.
- Title ribbons are given upon earning the 3rd qualifying leg in an element or game, or upon completion of a level. See Section 15.1D for further explanation.
- HiT- HIGH in Trial, High Champion & High Rescue Awards will be offered. 2-4th HiT are NOT Offered.
 See Section 18.2 of the current Rulebook for requirements.

CLEAN UP AFTER YOUR DOG!: Dispose of waste in appropriate containers. Do NOT let your dog pee on items we have to touch! We are guests on this property, please be respectful.

DESTRUCTION/DAMAGE to Search Area: Section 17.7B -Handlers will be expected to make financial reparations to the event host or owner of the item that will cover the cost of replacement or repair to the damaged item. ie. vehicles, furniture.

CRATING: Inside air-conditioned crating space is available. **Crating MUST BE in an enclosed crate.** Exercise pens (xpens) are NOT PERMITTED for safety reasons. If crating from participant's vehicle, you must be prepared to provide shade and water throughout the trial. It's Florida, it's HOT!

ELIGIBLE DOGS: See Section 6.1 of the Rulebook. If bringing a bitch in season, **please inform the trial secretary prior to the trial** and inform all exhibitors at the judge's briefing.

INELIGIBLE DOGS: See Section 6.4 of the Rulebook.

FOOD: Bring your lunch as the closest store is 5+ miles away.

PAYMENTS & WAIVERS: Checks and Waiver GUARANTEE your spot in the trial. Please make out to BCDTC and mailed with the Waiver to Marilyn Strout, 3794 Long Grove Ln., Port Orange, FL 32129. If not received by closing date, the entry is NOT accepted for the trial.

REACTIVE DOGS: Canine Star Training Academy accepts the entries of reactive dogs in USCSS™ trials. These dogs may not be crated in the general crating area and may have to be crated in the handler's car. Reactive dogs will be run first or last in the trial and all other dogs must be crated while the reactive dogs are preparing for the search. A 10-minute break will be given after the reactive dogs have run and are again crated to give the other teams time to prepare for their runs. USCSS™ suggests that reactive dogs wear red bandannas.

REFUNDS & EVENT CANCELLATION: No refunds allowed after the pre-entry closing date except in the case of injured dogs (<u>Veterinary note required</u>). Refund will be 50% and those seeking a refund must request by 8:30 am on the day of the trial. Vet note must be received by Monday after trial and can be sent to the Trial Chairman. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee. Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood, hurricane or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event may be canceled or postponed. We will make every attempt to contact entrants and inform them of the cancellation or postponement.

SCHEDULE: Novice - Intermediate - Advanced -Games - Senior - Master - Extreme. Judge assignments & run order will be determined after the closing date and prior to the day of the trial. Anticipated Check In time "around 8:30 am" with a CSD Briefing at 8:50 am. First Dog Team(s) on the line at 9am. Staggered Arrival Times are planned. The trial will be held indoors & outdoors. Surfaces used for searches will be wood, metal, concrete, dirt, and grass. No stairs are involved.

NO SMOKING/VAPING/ ALCOHOLIC BEVERAGES at this facility or on the grounds.



Steps for Joining USCSS™, Registering Dog and Entering this Trial

- 1. All competitors must become a member of USCSS™, which is **FREE**! Competitors may join here: http://members.uscaninescentsports.com/signup.
- Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here: http://members.uscaninescentsports.com/login
- 3. When logged into their account on the USCSS™ website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button. Or, enter via the "Enter This Trial" option for the trial, on the <u>Upcoming USCSS Events</u> page on the website.
- 4. Competitors then select which dog they are entering and select which Classes and/or Games they are entering.
- **T (Titling)** is for teams wanting to earn qualifying legs (scores) towards titles, placements/ribbons and be eligible for High in Trial awards (if all criteria are met).
- FLO (For Legs Only) is for teams wanting to earn qualifying legs (scores) towards titles, but not placements/ribbons. You might choose this if you already have your title or are running an upper level dog at a lower level and possibly allowing less experienced teams a better chance to place. Judges MUST run FLO in any trial in which they are judging. FLO runs are not credited towards High in Trial (HiT) awards.
- **FEO (For Exhibition Only)** is for a team wanting to run two (2) dogs in the same class/level, or a team wanting to "practice". No qualifying leg (score) is earned, and no placement/ribbon is awarded. If you are running two (2) dogs in the same class/level, the dog running for "practice" MUST be selected as FEO and will run AFTER the titling dog.

Competitors will then receive a 1st computer generated confirmation email with details regarding their entry. They will then receive a 2nd email confirmation with PAYMENT DETAILS from the Trial Secretary mitchstrout@yahoo.com and instructions on how to submit payment for their entry. Payments and Waiver will be sent directly to the Trial Secretary, not USCSS™. Competitors should note that their spot in the trial will only be held once payment is made.
