Important - please read!

This is a VARIABLE Trial. You are eligible to earn legs in the elements towards a Variable Title (DDN, DDI. DDA). Three (3) legs are needed in each element to earn a Variable Title. If you already have your Classic title at a level, you may still enter any elements at that level and get legs towards your Element titles and overall Variable Title at that level. However, you must begin at the NOVICE level and work up through the higher levels. If you have any questions, please contact the Trial Secretary.

Hides and searches at a trial CAN NOT be talked about in any way shape or form while the trial is still running. It is not cool, not fair and down right disrespectful to do so.

Policy/Event Cancellation

No refunds allowed after the pre-entry closing date except in the case of injured dogs (**Veterinary note required**). Refund will be 50% and those seeking a refund must request by 8:30 am on the day of the trial. Vet note must be received by Monday after trial and can be sent to the Trial Chairman. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee. Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation.

Number of Entries

100 runs per day in this trial; Day of Show entries allowed- if there is room.

Dogs must have valid USCSS™ registration numbers to compete in this trial. You can register online and follow the payment instructions noted on the confirmation.

Steps for Joining USCSS™, Registering Dog and Entering this Trial

- 1. All competitors must become a member of USCSS™, which is **FREE**! Competitors may join here: http://members.uscaninescentsports.com/signup.
- 2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here: http://members.uscaninescentsports.com/login
- 3. LOGIN to your account & Select your dog & LEVEL

ENTRY INSTRUCTIONS - Enter ONLINE ONLY, SELECT LEVEL

FEO BOX – Only time you check this box if you want to enter a 2nd dog in the same class at the same level you are also entering your 1st dog.

FLO BOX - 2 REASONS you MIGHT check this box--

- a- You have earned a title in the ELEMENT at the level you are entering (passed 3 legs), or
- b. You are the Judge of the Element at the trial.

You will then received a confirmation email for every level you enter FROM USCSS. NO MONIES ARE PAID AT THIS TIME!!!!! IF YOU MAKE A MISTAKE, stop and wait until you hear from the Trial Secretary!

All Competitors – at this point, STOP & WAIT until you receive a confirmation from Happy Dog College (mitchstrout@yahoo.com) with further instructions on how to submit your payment & waiver.

Payments and signed waivers must be received by 6:00pm on the closing date. If not received on time, the competitor forfeits the on-line entry and must do day-of-entry (if trial is not full) with the increased entry fee. Any changes requested day of trial will be charged a \$5 fee.

SCHEDULE/RUN ORDER WILL BE DETERMINED AFTER ENTRIES CLOSE

It is the Competitor's responsibility to be familiar with the Rules and Regulations for USCSS. http://www.uscaninescentsports.com/

You are responsible for anything that is said at the briefing regardless of whether you attend it. You are also responsible for knowing when it's your turn to compete at the trial.

AWARDS A qualifying ribbon will be given at the end of your run.

1-4th Placements per class & high in trials awards, will be presented AFTER each level is judged.

HIGH in Trial for each level, Trial High Rescue & Trial High Champion Awards are NOT offered if there are less than 25 dogs entered in the trial.

If more than 25 dogs...High in Trial per level, Trial High Champion & Trial High Rescue dog must be entered in ALL classes offered at a given Level (minimum of 4) & qualify in at least 3 classes. 2nd, 3rd & 4th OVERALL Highs, ARE NOT OFFERED at this trial.

COVID 19 Protocols: MASKS COVERING YOUR NOSE and social distancing required.

CLEAN UP AFTER YOUR DOG! This is a Self-cleaning trial! Dispose of waste in appropriate containers outside the building. Do NOT let your dog pee on items we have to touch!

NO SMOKING/VAPING at this facility or on the grounds. The trial will be held indoors, and outdoors. Surfaces used for searches will be wood floors, carpet, concrete, dirt, and grass.

ELIGIBLE DOGS: The following dogs are eligible to compete in USCSS™ events:

- Dogs 6-months of age or older
- · Dogs of any breed, purebred or mixed breed
- · Blind, deaf or dogs with amputations or who use ambulatory carts
- Bitches in season, but they must wear panties and be kept separate from all other dogs and will be run at the end of their class/trial. If bringing a bitch in season, <u>please inform the trial secretary prior to the trial</u> and inform all exhibitors at the judge's briefing.

LEASH AND COLLARS

All dogs must be on a short leash and under control while on trial grounds except while showing.

Flexi/retractable leads are not permitted on USCSS™ sanctioned trial grounds. No choke chains, prong collars or halti/head collars are permitted.

Leashes of any length may be used while the dog is participating in a run during a Class, but they must be switched over to a 6' length leash when outside of the search area.

REACTIVE DOGS

Happy Dog College accepts the entries of reactive dogs in USCSS trials. These dogs may not be crated in the general crating area and may have to be crated in the handler's car. Reactive dogs will be run first or last in the trial and all other dogs must be crated while the reactive dogs are preparing for the search. A 10-minute break will be given after the reactive dogs have run and are again crated to give the other teams time to prepare for their runs. USCSS™ suggests that reactive dogs wear red bandannas.
