one dog for titling, all other dogs must be run FEO.\*\* If you want to run Intermediate you cannot run FEO in Novice

### **How to Join USCSS™, Register Dogs and Enter this Trial:**

1. All competitors must become a member of USCSS™, which is free. Competitors may join here: <http://members.uscaninescentsports.com/signup>.
2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here: <http://members.uscaninescentsports.com/login?redirectTo=http://members.uscaninescentsports.com/dog/register>
3. When logged into their account on the USCSS™ website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button.
4. Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.
5. Competitors will then receive a confirmation email with details regarding their entry. We are only accepting CHECKS for payment. ***All payments will be sent directly to the trial host***, not USCSS™. Competitors should note that their spot in the trial will only be held once payment is made.

*To earn your Novice Classic title you need to enter ALL 4 classes in one trial. If you do NOT q in all 4, or you enter 3 classes or less, your qs will still earn you a leg towards your Variable title in that element! Make sure to read the RULES so you know what you are entering!*

## **Intermediate Classes offered on April 15, 2018**

- (1) - *Exterior*
- (1) - *Vehicle*
- (1) - *Container*
- (1) – *Interior*

*To earn your Intermediate Classic title you need to enter ALL 4 classes in one trial, as above. You MUST have earned your DDCN before you can enter Intermediate.*

**Check-in time is 10:45AM | Briefing time is 11:20AM | First dog on the line at 11:40AM; note Novice Volunteers' dogs will run first**

**Dogs must have a valid USCSS™ registration number to compete in this trial. FOR day of show entries, the most important thing is to have your dog's registration number ready the morning of the trial. You can't enter the event without the dog's registration number! Handler may run multiple dogs, but titling dog must be run first.**

- High Scoring Rescue rosette for Novice and Intermediate
- High Scoring Champion of Record in Novice and Intermediate
- 1st - 4th place overall; For the Novice level trials, placements will be awarded separately to Novice A & Novice B competitors
- 1st - 4th place per class
