Multiple dogs with the same handler in the same level are allowed. Titling /FLO dog must be run first. For Exhibition Only (FEO) entries are accepted and run last.

This is a **CLASSIC Trial**. You **MUST** enter all 4 elements at a single level in order to earn the Classic Title. However, any and all Q's earned will also count towards the general USCSS Variable title requirements. If you have any questions, after checking the rule book contact the Trial Secretary for additional clarification.

Entry and Closing: Entry will be available through the USCSS website (see links above). Entries will be awarded on a first received basis. A waitlist will be maintained for this trial if entries exceed 25 dogs per element/game. Trial closes on Friday, November 20, 2026 at 5:00PM CST. Day of Show entries will be accepted if room is available.

Cancellations: Full refund minus \$25 administrative fee for all cancellations up to November 20, 2026. 50% refund after November 20, 2026 if the host can fill your spot. No refund after November 27, 2026. No refund in the event that a dog is absent, disqualified, excused or barred from competition on the day of the event. Payment processing fees will not be refunded.

Safety: All dogs must be on a 6' or shorter leash when not participating in a search. EVERY dog MUST maintain a minimum of 6' distance from all other dogs at ALL TIMES.

Please note that Bitches In Season may run in a trial. They must wear panties and they will run last in the run order. PLEASE ALERT YOUR TRIAL SECRETARY AS SOON AS POSSIBLE IF YOU WILL BE RUNNING A BIS.

Arrival and Check-In Time:

A final details email will be sent approximately two weeks prior to the trial and will include final arrival and scheduling details.

Awards:

Please note that ribbons must be picked up the day of the trial; they will not be mailed or delivered by the trial host.

- **1st - 4th Place** for every search
- **New Element Titles** (3 Q's in any element or game)

- **DDCx** – Detective Dog Classic. Passing all 4 searches at the same level in the same day. X denotes the number of Classic Titles earned.
- **DDx** – Detective Dog. Earn all 4 Element titles at the same level. X denotes the number of Variable Titles earned.
- **High In Trial** – Must be entered in all classes at the same level (Intermediate **AND/OR** Senior) and both games to be eligible.
