Multiple dogs allowed, titling dog must be run first For Exhibition Only entries taken | Day of Show entries allowed only if there is room

Registration, Entry, and Closing:

Entries will be awarded on a first-come-first-serve basis, of all entries received by the opening date and the closing date, which is November 7, 2022(or when the trial fills). Trial is open now.





Dogs must have valid USCSS tm registration numbers to compete in this trial. You must register online and follow the payment instructions noted on the confirmation.

Steps for joining USCSS tm, Registering Dog and Entering this Trial:

1. All competitors must become a member of USCSSTM, which is free. Competitors may join here: http://members.uscaninescentsports.com/signup.

2. Competitors must then register their dog(s) through the USCSSTM website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here:

3. When logged into their account on the USCSSTM website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button.

4. Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.

5. Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSSTM. The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.

- The above rosette's will only be awarded if there are 150 or more runs for the day.
