### **Classes offered on April 8, 2023**

- *Container - All levels - 2 – AM/PM*
- *Interiors – All levels- 2 – AM/PM*
- *Exterior= All levels- 2 – AM/PM*
- *Vehicles – all levels - 2 – AM/PM*

*You must enter all 4 classes in the same trial to earn you classic title. You may enter two different levels, or run two different dogs – one in each trial.*

### **Refund Policy/Event Cancellation**

No refunds allowed after the pre-entry closing date except in the case of injured dogs

**(Veterinary note required)**. Refund will be 50% and those seeking a refund must request by 8:30 am on the day of the trial. Vet note must be received by Monday after trial and can be sent to Kim at [luckydogevents@gmail.com](mailto:luckydogevents@gmail.com).

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee. Every attempt will be made to hold this event as scheduled. In the event of an “act of God” such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation.

### **Number of Entries:**

**150** runs per Judge per day | Multiple dogs allowed, 2<sup>nd</sup> dog must run FEO, if running in the same nested group.. Titling dog must be run first | For Exhibition Only entries taken  
| Day of Show entries allowed if there is room.

### **Registration Entry and Closing:**

Entries will be awarded on a first come, first serve basis, of all entries received between the opening date and the closing date, which is March 28, 2023. Trial is open now

**Dogs must have valid USCSS™ registration numbers to compete in this trial. You can and should (whenever possible) register online and follow the payment instructions noted on the confirmation, we are only accepting checks at this time.**

### **Steps for Joining USCSS™, Registering Dog and Entering this Trial:**

1. All competitors must become a member of USCSS™, which is free. Competitors may join here: <http://members.uscaninescentsports.com/signup>.
2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here:

3. When logged into their account on the USCSS™ website, competitors may then scroll down to the “LOCAL EVENTS” section, find the trial they are interested in entering and click on the ENTER button.
4. Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.

5. Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS™. The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.

**You are responsible for anything that is said at the briefing regardless of whether you attend it.**

**You also are responsible for ensuring your entries are correct. Any changes should be emailed mail to the secretary before the closing date. Any changes requested after close or day of will be charged a \$5 fee.**

## **AWARDS**

- High in Trial rosette
  - Above will only be awarded if there are 150 per trial
  - High Rescue in Trial rosette – only awarded if there are 150 or more runs per trial
  - High Champion of record rosette- only awarded if there are 150 or more runs per trial
  - Dogs must be entered in all 4 classes per trial, que in 4 out of 4 classes per trial and minimum of 4 classes at the same level to be eligible for any HIT awards
  - 1st - 4th place per class
- All ribbons must be picked up day of trial. No ribbons will be mailed out.**

### **Exhibitor Information:**

The following dogs are eligible to compete in USCSS™ events:

- Dogs 6-months of age or older
- Dogs of any breed, purebred or mixed breed
- Blind, deaf or dogs with amputations or who use ambulatory carts
- Bitches in season but they must wear panties and be kept separate from all other dogs and will be run at the end of their class/trial. If bringing a bitch in season, **please inform the trial secretary prior to the trial** and inform all exhibitors at the judge's briefing.
- Reactive dogs, and USCSS™ suggests they wear red bandannas

### **Leash and Collars:**

All dogs must be on a short leash and under control while on trial grounds except while showing. **Flexi/retractable leads are not permitted on USCSS™ sanctioned trial grounds. No choke chains, prong collars or halti/head collars are permitted at Lucky Dog Events.** Leashes of any length may be used while the dog is participating in a run during a Class, but they must be switched over to a 6' length leash when outside of the search area.

There is **NO SMOKING** in this facility or on the grounds. The trial will be held indoors, and outdoors. Surfaces used for searches will be rubber matting, wood floors, rugs, dirt, and grass.

## Crating

There will be no crating space available inside the building you must work out of your cars.

## PLEASE CLEAN UP AFTER YOUR DOG!

Dispose of waste in appropriate containers outside the building. Do NOT let your dog pee on items we have to touch! This is a rental, and we want to be able to come back.

Please bring adequate shade and water for you and your dogs.
