Dogs must have valid USCSS™ registration numbers to compete in this trial. Handler may run multiple dogs, but the titling dog must be run first.

AWARDS

- Qualifying ribbons will be awarded, self serve, at the end of your runs.
- 1st - 4th placement ribbons will be awarded for each Element and Game Class.
- Qualifying ribbons will be available
- High in Trial Awards:
 - High in Trial rosette (1st - 4th) will be awarded for each level of competition.
 - High Rescue in Trial rosette will be awarded for the entire trial
 - High Champion of record rosette will be awarded for the entire trial
 - Dogs must be entered in all classes offered and have no more than one non qualifying score to be eligible for any HIT awards
 - Dogs must be registered with USCSS as a Champion and/or Rescue to be eligible for those awards.
 - **NOTE:** USCSS™ feels that competitors should be eligible to earn HiT at no more than two (2) levels in a single trial, IF there are no games. Where games are offered, competitors should enter their games on the same entry form at the level that they would like to be eligible for HiT. If eligible

for multiple levels of High in Trial, competitors should confirm their intentions with the Trial Secretary (or Chief Score Room Person).

***HIGH IN TRIAL AWARDS ARE NOT BEING AWARDED FOR 125 RUNS, or fewer.**

* High in Trial placements may be announced via Facebook, depending on time, with ribbons Available to be picked up at a later time/trial. ***Ribbons will not be mailed.***

NOTE ABOUT COLLARS AND LEASHES

No choke chains, prong collars or halti/head collars are permitted during searches. Collars may have tags. Leashes of any length (including Flexis) may be used while the dog is actively participating in search, but they must be switched over to a 6' (maximum) length leash when outside of the search area.

LUNCH

We will plan a brief lunch at between levels at the Judge's discretion. We will not be offering a potluck. There are multiple places to get food within 4 miles.

VOLUNTEERS

We cannot hold our Scent Work trials without volunteers! All-day volunteers have the opportunity to run their dog first and will participate in our volunteer raffle. Please let either Jen or Barb know if you can help!

Steps for Joining USCSS™, Registering Dog and Entering this Trial:

1. All competitors must become a member of USCSS™, which is free. Competitors may join here: <http://members.uscaninescentsports.com/signup>.
2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here: <http://members.uscaninescentsports.com/login?redirectTo=http://members.uscaninescentsports.com/dog/register>
3. When logged into their account on the USCSS™ website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button. Or, enter via the "Enter This Trial" option for the trial, on the [Upcoming USCSS Events](#) page on the website.
4. Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.

- ★ **T (Titling)** is for teams wanting to earn qualifying legs (scores) towards titles, placements/ribbons and be eligible for High in Trial awards (if all criteria are met).
- ★ **FLO (For Legs Only)** is for teams wanting to earn qualifying legs (scores) towards titles, but not placements/ribbons. You might choose this if you already have your title or are running an upper level dog at a lower level and possibly allowing less experienced teams a better chance to place. **Judges MUST run FLO in any trial in which they are judging.** FLO runs are not credited towards High in Trial (HiT) awards.
- ★ **FEO (For Exhibition Only)** is for a team wanting to run for "practice" or for handlers running more than one dog in the same class/level. No qualifying legs (scores) are earned, and no placements/ribbons will be awarded.

5. Competitors will then receive an automated confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS™. The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.
