**Leash and Collars:**

All dogs must be on a short leash and under control while on trial grounds except while showing. **Flexi/retractable leads are not permitted on USCSS™ sanctioned trial grounds. No choke chains, prong collars or halti/head collars are permitted at Lucky Dog Events.** Leashes of any length may be used while the dog is participating in a run during a Class, but **they must be switched over to a 6' length leash when outside of the search area.**
