Important – please read!

SAFETY, COLLARS & LEASHES: **Flexi/retractable leads are ONLY permitted during a search.** All dogs must be on a 6' or shorter fixed-length leash when not participating in a search. Dogs **MUST** be switched over to a 6' length or shorter leash when outside of the search area. Choke chains, prong collars or halti/head collars are **NOT** permitted during searches. Leashes of any length may be used while the dog is participating in a search. **EVERY** dog **MUST** maintain a minimum of 6' distance from all other dogs at **ALL TIMES**.

AWARDS: Ribbons will not be mailed.

- A qualifying ribbon will be given at the end of your run.
- 1st-4th place per class.
- **Title ribbons are given upon earning the 3rd qualifying leg in an element or game, or upon completion of a level.** See Section 15.1D for further explanation.
- # Tabs **MAY** awarded in lieu of title ribbons beyond the first title. ie. CN would receive a New Title ribbon; CN2 would receive a #2 tab. DDN would receive a New Title ribbon; DDN2 would receive a #2 tab.
- **HIT-** HIGH in Trial, High Champion & High Rescue Awards are offered, 2-4th are **NOT** awarded.

CLEAN UP AFTER YOUR DOG!: Dispose of waste in appropriate containers. Do **NOT** let your dog pee on items we have to touch! We are guests on this property, please be respectful.

DESTRUCTION/DAMAGE to Search Area: Section 17.7B -Handlers will be expected to make financial reparations to the event host or owner of the item that will cover the cost of replacement or repair to the damaged item. ie. vehicles, furniture.

CRATING: Crating from participant's vehicle, you must be prepared to provide shade and water throughout the trial. It's Florida, it's **HOT!**

ELIGIBLE DOGS: See Section 6.1 of the Rulebook. If bringing a bitch in season, **please inform the trial secretary ASAP prior to the trial** and inform all exhibitors at the judge's briefing.

INELIGIBLE DOGS: See Section 6.4 of the Rulebook.

PAYMENTS & WAIVERS: **Checks and Waiver GUARANTEE your spot in the trial.** Please make out to **HDC** and mailed with the Waiver to **Marilyn Strout, 3794 Long Grove Ln., Port Orange, FL 32129** . **If not received by closing date, the entry is NOT accepted for the trial.**

REACTIVE DOGS: **Happy Dog College** accepts the entries of reactive dogs in USCSS™ trials. These dogs will be crated in the handler's car. Reactive dogs will be run first in the trial and all other dogs must be crated while the reactive dogs are preparing for the search. A 10-minute break will be given after the reactive dogs have run and are again crated to give the other teams time to prepare for their runs. HDC asks that reactive dogs wear red bandannas.

REFUNDS & EVENT CANCELLATION: No refunds allowed after the pre-entry closing date except in the case of injured dogs (**Veterinary note required**). Refund will be 50% and those seeking a refund must request by 8:30 am on the day of the trial. Vet note must be received by Monday after trial and can be sent to the Trial Chairman. Entry fees will not be refunded in the event that a dog is disqualified, excused or barred from competition by action of the Event Committee. Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood, hurricane or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event will be canceled or postponed. We will make every attempt to contact entrants and inform them of the cancellation or postponement.

SCHEDULE: Judge assignments, schedule and run order will be determined after the closing date. Run Order will be emailed no later than Wed. prior to the day of the trial. Anticipated Check In time "around 8:30 am" with a CSD Briefing at 8:50 am. First Dog Team(s) on the line at 9am.

NO SMOKING/VAPING: At this facility or on the grounds.

Steps for Joining USCSS™, Registering Dog and Entering this Trial

1. All competitors must become a member of USCSS™, which is **FREE!** Competitors may join here: <http://members.uscaninescentsports.com/signup>.
2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here: <http://members.uscaninescentsports.com/login>
3. Once logged into your account on the USCSS™ website, you may enter via TRIALS tab> [Upcoming USCSS Events](#) page on the website.
4. Competitors then select which dog they are entering and select which Classes and/or Games they are entering.
 - **T (Titling)** is for teams wanting to earn qualifying legs (scores) towards titles, placements/ribbons and be eligible for High in Trial awards (if all criteria are met).
 - **FLO (For Legs Only)** is for teams wanting to earn qualifying legs (scores) towards titles, but not placements/ribbons. You might choose this if you already have your title or are running an upper level dog at a lower level and possibly allowing less experienced teams a better chance to place. **Judges MUST run FLO in any trial in which they are judging.** FLO runs are not credited towards High in Trial (HiT) awards.
 - **FEO (For Exhibition Only)** is for a team wanting to run two (2) dogs in the same class/level, or a team wanting to "practice". No qualifying leg (score) is earned, and no placement/ribbon is awarded. If you are running two (2) dogs in the same class/level, the dog running for "practice" MUST be selected as FEO and will run AFTER the titling dog.

Competitors will then receive a 1st computer generated confirmation email with details regarding their entry. They will then **receive a 2nd email confirmation with PAYMENT DETAILS from the Trial Secretary** mitchstrout@yahoo.com and instructions on how to submit payment for their entry. Payments and Waiver will be sent directly to the Trial Secretary, not USCSS™. **Competitors should note that their spot in the trial will only be held once payment is made. Please make sure mitchstrout@yahoo.com is in your address book so that our emails do not go to your SPAM folder.**
