**Important – please read!** 

It is the Competitor's responsibility to be familiar with the Rules and Regulations for USCSS™.

### USCSS-Rules-Ver.-3.0.pdf

This is a **CLASSIC Trial**. You MUST enter all 4 elements at a single level in order to earn the Classic Title. However, any and all Q's earned will count towards the general USCSS Variable title requirements. If you have any questions, after checking the rule book contact the Trial Secretary for additional clarification.

**SAFETY:** All dogs must be on a 6' or shorter leash when not participating in a search. EVERY dog MUST maintain a minimum of 6' distance from all other dogs at ALL TIMES.

**AWARDS:** Ribbons will not be mailed. A qualifying ribbon will be given at the end of your run. 1st - 4th place per class. All legs earned at a higher level, without previously earned titles at the lower levels, are banked. Keep in mind that the progression through the levels in variable vs classic is separate. HIGH in TRIAL 1<sup>st</sup> place will be offered at all levels. High Champion and High Rescue will also be offered. HIGH in Trial 2-4th are NOT offered.

**CLEAN UP AFTER YOUR DOG!:** Dispose of waste in appropriate containers. Do NOT let your dog pee on items we have to touch!

**DESTRUCTION/DAMAGE to Search Area**: Section 17.6B - Handlers will be expected to make financial reparations to the event host or owner of the item that will cover the cost of replacement or repair to the damaged item. ie. vehicles, furniture.

**COLLARS & LEASHES:** Flexi/retractable leads are ONLY permitted during a search. Choke chains, prong collars or halti/head collars are NOT permitted during searches. Leashes of any length may be used while the dog is participating in a search. Dogs MUST be switched over to a 6' length or shorter leash when outside of the search area.

CRATING: Crating will be INDOORS (air conditioned).

**ELIGIBLE DOGS:** The following dogs are eligible to compete in USCSS™ events:

- Dogs 6-months of age or older
- Dogs of any breed, purebred or mixed breed
- Blind, deaf or dogs with amputations or who use ambulatory carts
- Bitches in season, but they must wear panties and be kept separate from all other dogs and will be run at the end of their class/trial. If bringing a bitch in season, <u>please inform the trial secretary prior to the trial</u> and inform all exhibitors at the judge's briefing

**FOOD:** Bring your lunch as the closest store is 5+ miles away. If you'd like to share a bowl/plate of munchies, that would be awesome!

**PAYMENTS & WAIVERS:** Checks made out to **Happy Dog College** and mailed with the Waiver to **Marilyn Strout, 3794 Long Grove Ln., Port Orange, FL 32129**. Both must be received *within 10 days AFTER Date of Entry Confirmation* Email from Trial Secretary.

**REACTIVE DOGS:** Happy Dog College accepts the entries of reactive dogs in USCSS™ trials. These dogs may not be crated in the general crating area and may have to be crated in the handler's car. Reactive dogs will be run first or last in the trial and all other dogs must be crated while the reactive dogs are preparing for the search. A 10-minute break will be given after the reactive dogs have run and are again crated to give the other teams time to prepare for their runs. USCSS™ suggests that reactive dogs wear red bandannas.

**REFUNDS & EVENT CANCELLATION:** Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood, hurricane or fire, or civil disturbances or any other causes beyond the control of the organizing

committee, the event may be canceled or postponed. We will make every attempt to contact entrants and inform them of the cancellation or postponement. Refunds will be processed up to 1 hr prior to start of trial.

**SCHEDULE**: Final Judge assignments & run order will be determined after the closing date on the day of the trial. Anticipated Check In time "around 7:45 am with a CSD Briefing at 8:15 am. First Dog Team on the line at 8:30 am. Details will be emailed in Welcome to Trial on April 24, 2024.

**NO SMOKING/VAPING/ALCOHOLIC BEVERAGES:** At this facility or on the grounds. The trial will be held indoors & outdoors. Surfaces used for searches will be wood, metal, concrete, dirt, and grass. No stairs are involved.
