Multiple dogs with same handler allowed in the same class/level. Titling dog (Q ribbon and placement) and For Legs Only (FLO) entries (Q ribbon, no placement) must be run first; 2<sup>nd</sup> dog runs For Exhibition Only (FEO).

## Important – please read!

It is the Competitor's responsibility to be familiar with the Rules and Regulations for USCSS™. [USCSS Rule Book 3.1](#)

This is a **VARIABLE Trial**. Any and all Q's earned will count towards the general USCSS Variable title requirements. If you have any questions, after checking the rule book contact the Trial Secretary for additional clarification.

**SAFETY:** All dogs must be on a 6' or shorter leash when not participating in a search. EVERY dog MUST maintain a minimum of 6' distance from all other dogs at ALL TIMES.

**AWARDS:** AWARDS: Ribbons will not be mailed. A qualifying ribbon will be given at the end of your run. • 1st-4th place per class. • Title ribbons are given upon earning the 3rd qualifying leg in an element or game, or upon completion of a level. See Section 15.1D for further explanation. • # Tabs are also awarded beyond the first title up to the 5th title, ie. CN5, but not for CN6 HiT- HIGH in TRIAL 1st place is offered at all levels. High Champion and High Rescue are also offered. HIGH in Trial 2-4th are NOT offered.

**CLEAN UP AFTER YOUR DOG!:** Dispose of waste in appropriate containers. Do NOT let your dog pee on items we have to touch!

**DESTRUCTION/DAMAGE to Search Area:** Section 17.6B - Handlers will be expected to make financial reparations to the event host or owner of the item that will cover the cost of replacement or repair to the damaged item. ie. vehicles, furniture.

**COLLARS & LEASHES:** **Flexi/retractable leads are ONLY permitted during a search.** Choke chains, prong collars or halti/head collars are NOT permitted during searches. Leashes of any length may be used while the dog is participating in a search. Dogs MUST be switched over to a 6' length or shorter leash when outside of the search area.

**CRATING:** **Crating must be in an enclosed crate!** X-pens are NOT PERMITTED for safety reasons. All crating will be out of your vehicle. Plenty of total shade

**ELIGIBLE DOGS:** The following dogs are eligible to compete in USCSS™ events:

- Dogs 6-months of age or older
- Dogs of any breed, purebred or mixed breed
- Blind, deaf or dogs with amputations or who use ambulatory carts
- Bitches in season, but they must wear panties and be kept separate from all other dogs and will be run at the end of their class/trial. If bringing a bitch in season, **please inform the trial secretary prior to the trial** and inform all exhibitors at the judge's briefing

**INELIGIBLE DOGS:** See Section 6.4 of the rule book for more detail.

Dogs aggressive towards people or other dogs.

Dogs who are lame, have stitches, open wounds or are ill

Lactating bitches.

**FOOD:** Bring your lunch as the closest store is 5+ miles away. We plan to move quickly through the Elements. If you'd like to share a bowl/plate of munchies, that would be awesome!

**PAYMENTS & WAIVERS:** Checks made out to **KIM FLOYD** and mailed with the Waiver to **Kim Floyd, 7004 DeMay Street, Riverview, FL 33578**. Paid entry fees guarantee acceptance.

**REACTIVE DOGS:** **Love My Angel Pups** accepts the entries of reactive dogs in USCSS™ trials. These dogs may not be crated in the general crating area and may have to be crated in the handler's car. Reactive dogs will be run first or last in the trial and all other dogs must be crated while the reactive dogs are preparing for the search. A 10-minute break will be given after the reactive dogs have run and are again crated to give the other teams time to prepare for their runs. USCSS™ suggests that reactive dogs wear red bandannas.

**REFUNDS & EVENT CANCELLATION:** Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood, hurricane or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event may be canceled or postponed. We will make every attempt to contact entrants and inform them of the cancellation or postponement. Refunds will be processed up to 1 hr prior to start of trial. Entry fees will NOT be refunded in the event that a dog is disqualified, excused or barred from competition by the Event Committee

**SCHEDULE:** Anticipated Check In time "around 8:00 AM with a CSD briefing at 8:50 AM. First Dog Team(s) on the line at 9:00 AM. **The order of classes and tentative run order** will be determined after the closing date and details emailed on 03/26/25 (Wednesday before the trial). However, nothing is set in stone. Weather and site conditions may impact the order on the day of the trial.

**NO SMOKING/VAPING/ALCOHOLIC BEVERAGES:** At this facility or on the grounds. The trial will be held indoors & outdoors. Surfaces used for searches will be wood, metal, concrete, dirt, and grass. A few stairs may be involved.
