Multiple dogs with same handler allowed in the same class/level, titling dog must be run first; 2nd dog runs For Exhibition Only (FEO). For Legs Only (FLO) entries/NO RIBBONS/NO PLACEMENT are also accepted.

Important – please read!

Please send an email to Kim Floyd: johmanda@tampabay.rr.com AFTER you have entered online. I am not getting confirmation from USCSS with your entries. If you have trouble entering on-line, send an email to Julie Sandoval: easytospotdals@gmail.com to facilitate your entry.

It is the Competitor's responsibility to be familiar with the Rules and Regulations for USCSS[™]. USCSS Rule Book 3.1

SAFETY: All dogs must be on a 6' or shorter leash when not participating in a search. EVERY dog MUST maintain a minimum of 6' distance from all other dogs at ALL TIMES.

AWARDS: Ribbons will not be mailed. A qualifying ribbon will be given at the end of your run. 1st - 4th place per class will be awarded. All legs earned at a higher level, without previously earned titles at the lower levels, are banked. Keep in mind that the progression through the levels in variable vs classic is separate. HIT 1st place will be offered at all levels. HIT 2nd thru 4th places will NOT be offered.

CLEAN UP AFTER YOUR DOG!: Dispose of waste in appropriate containers. Do NOT let your dog pee on items we have to touch!

DESTRUCTION/DAMAGE to Search Area: Section 17.6B - Handlers will be expected to make financial reparations to the event host or owner of the item that will cover the cost of replacement or repair to the damaged item. ie. vehicles, furniture.

COLLARS & LEASHES: Flexi/retractable leads are ONLY permitted during a search. Choke chains, prong collars or halti/head collars are NOT permitted during searches. Leashes of any length may be used while the dog is participating in a search. Dogs MUST be switched over to a 6' length or shorter leash when outside of the search area.

CRATING: Inside air-conditioned crating is available. **Crating must be in an enclosed crate!** X-pens are NOT PERMITTED for safety reasons. If crating from a vehicle, be prepared to provide shade and water throughout the trial. There are some shade trees at the site. It's Florida, it's HOT

ELIGIBLE DOGS: The following dogs are eligible to compete in USCSS[™] events:

- Dogs 6-months of age or older
- Dogs of any breed, purebred or mixed breed
- Blind, deaf or dogs with amputations or who use ambulatory carts
- Bitches in season, but they must wear panties and be kept separate from all other dogs and will be run at the end of their class/trial. If bringing a bitch in season, <u>please</u> <u>inform the trial secretary prior to</u> <u>the trial</u> and inform all exhibitors at the judge's briefing

FOOD: Bring your lunch as the closest store is 5+ miles away. We plan to move quickly through the Elements. If you'd like to share a bowl/plate of munchies, that would be awesome!

PAYMENTS & WAIVERS: Checks made out to <u>KIM FLOYD</u> and mailed with the Waiver to Kim Floyd, 7004 DeMay Street, Riverview, FL 33578. Paid entry fees guarantees acceptance.

REACTIVE DOGS: Love My Angel Pups accepts the entries of reactive dogs in USCSS[™] trials. These dogs may not be crated in the general crating area and may have to be crated in the handler's car. Reactive dogs will be run first or last in the trial and all other dogs must be crated while the reactive dogs are preparing for the search. A 10-minute break will be given after the reactive dogs have run and are again crated to give the other teams time to prepare for their runs. USCSS[™] suggests that reactive dogs wear red bandannas.

REFUNDS & EVENT CANCELLATION: Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood, hurricane or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event may be canceled or postponed. We will make every attempt to contact entrants and inform them of the cancellation or postponement. Refunds will be processed up to 1 hr prior to start of trial.

SCHEDULE: Anticipated Check In time "around 8:30 AM with a CSD briefing at 8:50 AM. First Dog Team(s) on the line at 9:00 AM. **The order of classes and tentative run order** will be determined after the closing date and details emailed on June 25, 2025 (Wednesday before the trial). However, nothing is set in stone. Weather and site conditions may impact the order on the day of the trial.

NO SMOKING/VAPING/ALCOHOLIC BEVERAGES: At this facility or on the grounds. The trial will be held indoors & outdoors. Surfaces used for searches will be wood, metal, concrete, dirt, and grass. A few stairs may be involved.
