**Entries limited to 160 runs each day.**

*Pre-entries only, no day of show entries allowed.*

May 26: Handlers may enter one Novice and one Intermediate dog for titling runs – there will be separate search areas for Novice and Intermediate Elements in the Classic Trial. Handlers may enter additional dogs For Exhibition Only (FEO).

May 27: Handlers may enter all five games for titling runs (each game will be in a separate search area). Handlers may enter multiple dogs; if two dogs are in the same Games Class, the titling dog will be run first.

## Registration Entry and Closing:

Entries open January 3, 2018 and close when trial fills or on May 10, 2018.

Entries will be awarded by First Come First Served. If trial fills, additional entries will be placed on a wait list.

**Dogs must have valid USCSS™ registration numbers to compete.**

**Handler may run multiple dogs in the same class/level, but titling dog must be run first.**

### Steps for Joining USCSS™, Registering Dog and Entering this Trial:

1. All competitors must become a member of USCSS™, which is free. Competitors may join here: <http://members.uscaninescentsports.com/signup>.
2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here: <http://members.uscaninescentsports.com/login?redirectTo=http://members.uscaninescentsports.com/dog/register>
3. When logged into their account on the USCSS™ website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button.
4. Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.
5. Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS™. The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.
