<u>Dogs must have valid USCSS</u>[™] registration numbers to compete in this trial. Handlers may, space permitting, run multiple dogs; dogs competing for titles must run first; For Exhibition Only (FEO) dogs run afterwards.

Steps for Joining USCSS[™] , Registering Dog and Entering this Trial:

1. All competitors must become a member of USCSS [™] , membership is free. Competitors may join here: <u>http://members.uscaninescentsports.com/signup</u>

2. Competitors must then register their dog(s) through the USCSS[™] website. Each registration includes a one-time \$25.00 fee.

3. When logged into their account on the USCSS[™] website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the enter button.

4. Competitors may then select which dog they are entering and select which classes and/or games they are entering.

5. Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS[™]. The confirmation email will specify how payment will be made (it will be via PayPal). Competitors should note that their spot in the trial will only be held once payment is made.

<u>Parking</u>: Please follow directions from Parking Lot volunteer. There is plenty of space for parking, but there may be sight line issues depending on the level. The spaces in the lots are very tight, so smaller vehicles are recommended, <u>NO</u> campers or RVs. There is <u>NO</u> reactive dog parking at this site.

Trial Venue Information: The school is in the middle of an urban residential area and the residents do like to walk their dogs, a good thing, but may make for a busy time on some of the walk ways where we will have potty areas. So please be vigilant as you potty your dogs. Do not let them potty on lawns or property that humans may touch.

The trial will be held indoors and outdoors. Surfaces used for search will be carpet, wooden floors, tile, concrete, black top, wood chips, dirt, grass and gravel. There may be long walks to some of the search areas. This is a multi level school but it has an elevator to assist both the human and dog participants if needed, as well as ramps and stairs.

Cancellation Policy: No refunds are allowed for withdrawal from the trial after April 21, 2023 except in case of injured dog(s) (Veterinary note required).

Refunds prior to April 21, 2023 will be given if the spot in the class(es) entered can be filled from the Waitlist.

The refund will be the entry fee(s) paid less a \$15 processing fee per trial day for those seeking a refund before April 21, 2023.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.

Every attempt will be made to hold this event as scheduled. In the event of an "Act of God" such as flood, fire or civil disturbances, or any other causes beyond the control of the organizing committee, the event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation.

Unentered Dogs

Unentered dogs must remain in the competitor's vehicle during the trial day. There will be ample potty areas, but unentered dogs should not be allowed to "play", exercise, or train on the trial grounds.

Please if at all possible leave unentered dogs home.

<u>Smoking</u>

Smoking is not allowed on this trial site, including the use of e-cigarettes

Dog Policies

- All dogs must be on a 6' leash at all times when not being tested. NO flexi-leashes while not participating in a competition search.
- Dogs that need space from dogs may wear a red bandana, provided by the dog's handler, to help signal others that the dog needs extra space from dogs.
- Dogs will be toileted in designated areas and handlers must pick-up and dispose of waste.
- Dogs and handlers must stay in designated areas to avoid contaminating testing space, interrupting a test, or from viewing any part of the testing.
- Competitors should expect to keep their dogs confined in a crate or vehicle when not competing. The logistics of a trial typically do not allow for dogs to hang out on leash in between searches. Competitors should plan to provide their own shade using canopies or shade cloths.
- Refer to Location Details (above) for information on unentered dogs.

Females in Season

Will be allowed to run wearing "pants" at the very end of the running orders after all other dogs have been judged. Females in season will be parked and pottied in areas separate from the other dogs while at the trial if the location logistics permit. Handlers must contact mntsea23@gmail.com so plans can be made for the dog.

Volunteers: Every trial relies on Great Volunteers to run smoothly & efficiently. You can run your dog(s) and volunteer at these trials. Volunteers will be able to crate their dog inside the school for the rest of the day. Lunch will be provided for volunteers. The competitor also agrees to assume all financial liability that may be incurred by the USCSS due to the actions of themselves or their dogs regardless of the cause.



Sportsmanship

All competitors/handlers and spectators are expected to follow the rules of the USCSS and demonstrate good sportsmanship. This includes making sure the hide placements are unknown to the handler prior to testing and kept secret from other competitors. Please do not discuss hide placement or any details of a dog's performance that may provide information or clues to other handlers or may be overheard.
