Entry Cost:

Number of Entries:

Novice trial will be limited to 30 entries, Intermediate trial will be limited to 20 entries and Advanced trial will be limited to 15 entries. Same day move ups are **not** allowed. Games Day will be limited to 40 dogs

Multiple dogs allowed at one level **only** if all single dog handlers have all been accommodated, titling dog must be run first. For Exhibition Only (FEO) entries taken only if space is available. Day of Show entries **not** allowed.

Space permitting dogs may be entered in more than one level (Novice/Intermediate or Advanced) on Saturday.

You will be able to run two dogs for titles if the dogs are at different levels.

Registration Entry and Closing:

Entries will be awarded by random lottery for any class is oversubscribed. Entries must be received by **April 27**th, **2019** in order to be eligible for the random draw.

Steps for Joining USCSS™, Registering Dog and Entering this Trial:

- 1. All competitors must become a member of USCSS™, which is free. Competitors may join here: http://members.uscaninescentsports.com/signup.
- **3.** When logged into their account on the USCSS™ website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button.
- **4.** Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.
- 5. Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS™. The confirmation email will specify how payment will be made (it will be via PayPal Invoice) Competitors should note that their spot in the trial will only be held once payment is made.

Classes offered on Saturday, June 8th, 2019

Classic Trials (Container, Vehicle, Exterior + Interior) at the following levels:

- Novice
- Intermediate
- Advanced

Hides are not nested.

Classes offered on Sunday, June 9th, 2019

Games Classes Offered:

- (2) Go the Distance
- (2) Heap O' Hides
- (1) LudicrouSpeed

Hides are not nested.

Check-in time for Novice is 8:30 a.m. | Briefing time is 8:45 a.m. | First dog on the line at 9:30 a.m. Intermediate and Advanced check-in times TBD.

Dogs must have valid USCSS™ registration numbers to compete in this trial. Handler may, space permitting, run multiple dogs, but titling dog must be run first.

PARKING: The main parking lot is gravel with some shade. Dogs will be crated in your vehicle. Pop-ups in the main parking area can only be used so long as they do not take away parking spaces. Additional overflow + Reactive dog parking will be available in a nearby field. There is no shade in the field, but pop-ups are allowed.

Oversized vehicles will all be parked in the field. Be aware that some portions of the driveway to field are configured in such a way that the road may cause large RV's to drag on the ground.

LEASH POLICIES: All dogs must be on a short leash and under control while on trial grounds except while searching. Flexi/retractable leads are not permitted on USCSS™ sanctioned trial grounds. No choke chains, prong collars or halti/head collars are permitted at this event. Leashes of any length may be used while the dog is participating in a run during a Class, but they must be switched over to a 6' length leash when outside of the search area.

TRIAL VENUE INFORMATION:

There is **NO SMOKING** at Camp Waskowitz or anywhere on the grounds. The trial will be held indoors and outdoors. Surfaces used for searches will be vinyl floors, wood floors, dirt, grass, concrete and gravel. There may be long walks to some of the search areas on both trial days, with steep descents + ascents to the search locations.

AWARDS

- High in Trial rosette for Saturday only
- Dogs must be entered in a minimum of 4 classes on Saturday's trial to be eligible for any HIT awards
- 1st 4th place overall
- 1st 4th place per class

Dogs must be entered in a minimum of 4 classes to be eligible for any Classic Trial HIT awards on Saturday.

All ribbons must be picked up day of trial. No ribbons will be mailed out.

CANCELLATION POLICY:

No refunds are allowed for withdrawal from the trial after the May 15th, 2019 except in the case of injured dogs (Veterinary note required). Refunds prior to May 15th will be given if the spot in the class(es) entered can be filled from a Wait List. The refund will be the entry fee(s) paid less a \$25 processing fee for those seeking a refund before 8:30 am on May 15th, 2019. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee. Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation.

LUNCH

We will have lunch at approximately noon and will take breaks at the Judge's discretion. Northwest K9 Sniffers will host a location in the camp Dining Hall for competitors to consume their lunches. The club will provide desserts. Volunteer's will be provided lunch and drinks
