Dogs must have valid USCSS™, registration numbers to compete in this trial. You can register online and follow the payment instructions noted on the confirmation. Only online entries accepted for advance registration.

By registering for this trial, you agree to the Release of Liability Waiver at the end of this document.

Steps for Joining USCSS™, Registering Dog and Entering this Trial:

1. All competitors must become a member of USCSS™, which is free. Competitors may join here: <http://members.uscaninescentsports.com/signup>.
2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here:

3. When logged into their account on the USCSS™ website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button.
4. Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.
5. Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS™. The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.

Check in for Advance will be determined after close of entries.

NO GENERAL BRIEFING

PARKING:

Please follow the posted signs for parking. You may park anywhere in the designated area, please leave room for other vehicles, and park accordingly if you will not be staying all day. Parking is a dirt lot with no shade - plan accordingly.

You are free to potty your dog anywhere in the general parking area. Do not wander in the main stable area or come find us if you arrive early as we may be setting hides or running our dogs.



CRATING: Crating will be at your car.

NO SMOKING: No smoking ANYWHERE on the grounds. Vaping is ok.

LOCATION INFORMATION: This is a working stable. Ground may be uneven going from parking area to search sites.

The following dogs are eligible to compete in USCSS™ events:

- Dogs 6-months of age or older
- Dogs of any breed, purebred or mixed breed
- Blind, deaf or dogs with amputations or who use ambulatory carts.
- Bitches in season - must wear panties, be kept separate from all other dogs and run at the end of their class. If bringing a bitch in season **please inform the trial secretary prior to the trial.**
- Reactive dogs, USCSS™ suggests they wear red bandanas.

SAFETY, COLLARS & LEASHES: Flexi/retractable leashes are only permitted during a search. All dogs must be on a 6' or shorter leash when not participating in a search. Dogs **MUST** be switched over to a 6' length or shorter leash when outside of the search area. Choke chains, prong collars or halti/head collars are not permitted during searches. Leashes of any length may be used while the dog is participating in a search. **EVERY** dog **MUST** maintain a minimum of 6' distance from all other dogs at **ALL TIMES.**

DO NOT LET YOUR DOG GO UP TO ANY OF THE HORSES!

PAYMENTS & WAIVERS: Please sign the attached waiver and bring with you to the trial if you do not train with me or have not trialed at this location. Payment through Venmo to @Jinny-Chow.



Awards

- Qualifying ribbons will be available, self serve, at the end of your runs.
- 1st - 4th place per class will be awarded at the end of the trial
- New Title ribbons will be awarded
- High in Trial ribbon will be awarded if there are 50 or more runs for the day. Dogs must be entered and que in all four classes to be eligible for HIT.
