We will have a staggered check-in time and will share those times a couple of days before the trial day.

Dogs must have valid USCSS™ registration numbers to compete in this trial. Handler may run multiple dogs, but the titling dog must be run first.

AWARDS

- Qualifying ribbons will be awarded
- 1st - 4th Placement Rosettes will be awarded for each Element and Game Class.
- New Title Rosettes will be awarded
- ***HIGH IN TRIAL AWARDS ARE BEING AWARDED FOR THIS TRIAL***

NOTE ABOUT COLLARS AND LEASHES

No choke chains, prong collars or halti/head collars are permitted during searches. Collars may have tags. Leashes of any length (including Flexis) may be used while the dog is actively participating in search, but they must be switched over to a 6' (maximum) length leash when outside of the search area.

LUNCH

For the Love of Dogs NY will have lunch at approximately 12:30pm and will take breaks at the Judge's discretion. This venue is a religious school. Therefore we will be offering food for advanced purchase that is permitted to be eaten inside the facility. Any other food that is consumed (which is not Kosher) must be eaten outside of the school building or in your vehicles.

VOLUNTEERS

We cannot hold our Scent Work trials without volunteers!

All-day volunteers have the opportunity to run their dog(s) first and will be provided with refreshments.

NOTES ABOUT THE TRIAL LOCATION

- Parking: Please follow directions from the Check-In volunteer. There is plenty of space for parking, but we need everyone parking in the correct lot.
- The Trial is taking place at a religious school. Please be respectful of their property and their rules related to eating indoors. They require all food consumed inside to be Kosher. Please be sure the food you bring is consumed outside or in your vehicle.
- You must clean up after your dog and keep your dog leashed while you are on the grounds.
- The trial will be held indoors and outdoors. Surfaces used for searches will be concrete, black top, dirt, grass, and gravel. There may be long walks to some of the search areas.

CANCELATION POLICY

No refunds are allowed for withdrawal from the trial after October 5th, 2024, at 8 A.M. except in case of injured dog(s) (Veterinary note required). Prior to October 5, 2024, refunds will be given if the spot in the class(es) entered can be filled from the waitlist. The refund will be the entry fee(s) paid minus a \$25 processing fee. For cancellations that meet the above guidelines, refunds will be issued within 30 days of the request and no later than 14 days after the event date.

Steps for Joining USCSS™, Registering Dog and Entering this Trial:

1. All competitors must become a member of USCSS™, which is free. Competitors may join here: <http://members.uscaninescentsports.com/signup>.
2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here: <http://members.uscaninescentsports.com/login?redirectTo=http://members.uscaninescentsports.com/dog/register>
3. When logged into their account on the USCSS™ website, competitors may then go to the 'TRIALS' menu and click on the "UPCOMING USCSS EVENTS" section, find the trial they are interested in entering and click on the ENTER THIS TRIAL button.
4. Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.

★ **T (Titling)** is for teams wanting to earn qualifying legs (scores) towards titles, placements/ribbons and be eligible for High in Trial awards (if all criteria are met).



★ **FLO (For Legs Only)** is for teams wanting to earn qualifying legs (scores) towards titles, but not placements/ribbons. You might choose this if you already have your title or are running an upper level dog at a lower level and possibly allowing less experienced teams a better chance to place. **Judges MUST run FLO in any trial in which they are judging.** FLO runs are not credited towards High in Trial (HiT) awards.

★ **FEO (For Exhibition Only)** is for a team wanting to run for “practice” or for handlers running more than one dog in the same class/level. No qualifying legs (scores) are earned, and no placements/ribbons will be awarded.

5. Competitors will then receive an automated confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS™. The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.
