AWARDS: NOTE-Ribbons will not be mailed.

The following ribbons will be awarded:

- qualifying ribbon to be taken at the end of your run
- 1st – 4th place per Class
- Classic Title ribbon rosette (qualifying in all four elements)
- High In Trial ribbon rosette (you must enter all 5 classes to be eligible for high in trial. One NQ is allowed) Not awarded if 125 entries or less.

A Classic Title is awarded for qualifying runs in all 4 element classes. If a competitor does not earn their title at a Classic trial, any and all Q's earned will count toward general USCSS title requirements.

Steps for Joining USCSS, Registering Dog, and entering this trial

All competitors must become a member of USCSS, which is FREE! Competitors may join here: members.uscaninescentsports.com/signup Competitors must then register their dog(s) through the USCSS website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here: members.uscaninescentsports.com/login

- Competitors will receive email confirmation of entry from USCSS
- Competitors should note that their spot in the trial is secure only when both payment and liability waiver are received by the trial secretary.

Important – must read!

It is the Competitor's responsibility to be familiar with the most current rules and regulations for USCSS (Ver. 3.1 September 1, 2023)

SAFETY, COLLARS & LEASHES:

Flexi/retractable leads are ONLY permitted during a search. All dogs must be on a 6' or shorter leash when not participating in a search. Dogs MUST be switched over to a 6' length or shorter leash when outside of the search area. Choke chains, prong collars or halti/head collars are NOT permitted during searches. No electronic collars are allowed anywhere in the staging or search area.

- Leashes of any length may be used while the dog is participating in a search. • EVERY dog MUST maintain a minimum of 6' distance from all other dogs at ALL TIMES.

ELIGIBLE DOGS:

The following dogs are eligible to compete in USCSS events and must be registered with USCSS: • Dogs 6-months of age or older • Dogs of any breed, purebred or mixed breed • Blind, deaf or dogs with amputations or who use ambulatory carts • Bitches in season, but they must wear pants and be kept separate from all other dogs and will be run at the end of their class/trial. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

REACTIVE DOGS: Fit-N-Trim accepts the entries of reactive dogs in USCSS™ trials. USCSS™ suggests that reactive dogs wear red bandannas. Please notify the Trial Secretary, in advance, if you have a reactive dog.

LUNCH We don't typically take an official lunch break, but may take a short break at the Judge's discretion. There there are many food places nearby (fast food, also restaurants, pizza, and food stores).

Volunteers will help our Trial run smoothly. We need Timers, Gate Stewards, Score Runners, and Others. No Experience Required! No need to give up a day-volunteers get to run first in their class. Thanks in advance for your help. Lunch will be provided to those that volunteer. Please sign up to volunteer at this trial if you can. REFUNDS & EVENT CANCELLATION: • No refunds allowed after the closing date except in the case of injured dogs (veterinary note required). • Refund will be 50% and those seeking a refund must request by 8:30 a.m. on the day of the trial. Vet note must be received by Monday after trial and can be sent to the trial chairman. Entry fees will not be refunded unless the vet letter is received. • No refund in the event that a dog is absent, disqualified, excused or barred from completion on the day of the event. • Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation.

SCHEDULE: Dogs will run senior through novice. The elements will be run back-to-back with the game in the middle. Schedule subject to change. Check In starts at 8:00 a.m. Briefing will be at 8:30 a.m

CLEAN UP AFTER YOUR DOG! Dispose of waste in appropriate containers. Please Do not let your dogs eliminate anywhere near or on the buildings.

Crating There will be no crating at this event. Crating will be in your car.

Parking Sufficient parking area. Please watch for cone or signs indicating an area is off limits for parking-it may be a search area.
