Registration Entry and Closing:

Entries will be awarded on a first-come-first-served basis of entries submitted by Friday, November 15, 2025. Contact trial secretary Renee Elliott regarding day of show entries.

Steps for joining USCSS, Registering Dog and Entering This Trial:

- All competitors must become a member of USCSS, which is free. Competitors may join here: <http://members.uscaninescentsports.com/signup>.
- Competitors must then register their dogs through the USCSS website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here:

- When logged into their account on the USCSS website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button.
- Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.

Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS. The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.
