# **Entry Cost:**

\$19 per Element or Game Class

#### Number of Entries:

Entries limited to 300 runs each day.

Pre-entries only, no day of show entries allowed.

**September 8:** Handlers may enter one dog at each level for titling runs – there will be separate search areas for Novice, Intermediate and Advanced Elements in the Classic Trial. Handlers may enter additional dogs For Exhibition Only (FEO).

**September 9:** Handlers may enter all five games for titling runs (each game will be in a separate search area). Handlers may enter multiple dogs; if more than one dog is in the same Games Class, the titling dog will be run first and additional dogs run FEO.

### **Registration Entry and Closing:**

Entries open July 3, 2018 and close when trial fills or on August 25, 2018.

Online entries and payment.

Entries will be awarded by First Come First Served. If trial fills, additional entries will be placed on a wait list.

Dogs must have valid USCSS™ registration numbers to compete.

Handler may run multiple dogs in the same class/level, but titling dog must be run first.

## Steps for Joining USCSS™, Registering Dog and Entering this Trial:

- **1.** All competitors must become a member of USCSS™, which is free. Competitors may join here: <a href="http://members.uscaninescentsports.com/signup">http://members.uscaninescentsports.com/signup</a>.
- 3. When logged into their account on the USCSS™ website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button.
- **4.** Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.
- 5. Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS™. The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.

**Refund policy:** Full refund less \$10 administrative fee through August 3. 50% refund less \$10 administrative fee through August 15. No refunds after August 15.

Novice and Intermediate will run at the same time. Advanced will follow Intermediate.

#### **AWARDS**

Classic Trial: Separate HIT awards for each level provided there is a minimum of 25 dogs in the level. Dogs must be entered in a minimum of 4 classes at each trial to be eligible for HIT awards.

- High in Trial rosette and USCSS™ High in Trial cup
- High in Trial Rescue rosette
- High in Trial Champion of Record rosette
- 1st 4th place overall
- 1st 4th place per class
