Entry Cost: \$ 80 for 4 classic searches, pre-entry (must be received by April 5, 5PM)

\$25 for 4 classic searches Day of Show entry (available unless the trial has filled)

Entry in intermediate in the afternoon will be allowed for those passing novice in the morning, unless the trial is full.

Payment will be by paypal, you will be given instructions and a link after you submit your entry. Entry fees are not refundable after the closing date of the trial (April 5, 2021), except in case of a pandemic-related cancellation of the event. In that case, 100% of your entry fee will be refunded. Cash or checks accepted for day-of-trial entries.

Number of Entries: Entry is limited to 150 runs total.

NOTE: The novice and intermediate search areas will NOT be NESTED which means competitors can run for title in novice and intermediate level with different dogs.

Registration Entry and Closing: Trial will open for entry through the USCSS website. Entries will be awarded on a first received basis.

Steps for Joining USCSS™, Registering Dog and Entering this Trial:

1. All competitors must become a member of USCSS™, which is free. Competitors may join here:

2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here:

3. When logged into their account on the USCSS™ website, competitors may then scroll down to the “LOCAL EVENTS” section, find the trial they are interested in entering and click on the ENTER button.
4. Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.
5. Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS™. The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.

Classes offered:

AM Novice Classic Trial format
(1 search in each Interior/Exterior/Vehicle/Container)

PM intermediate Classic Trial format
(1 search in each Interior/Exterior/Vehicle/Container)

Schedule:

8:30AM - novice competitors arrive, dog in white runs the first searches
9:00 - short briefing for novice competitors, volunteers run their dogs,
followed by other competitors. Novice searches will be in the morning.

Intermediate handlers will be given an exact check-in time after pre-entries close. Check in time will not be before 12:30PM.

Remember, USCSS doesn't hold walk-throughs of the search areas.

If you arrive before 8:30am please do not enter the facility. Please keep 6 feet between yourself and others. Masks are required while participating, both indoors and outside.

We will not hold a potluck during this trial. Please bring your own lunch and snacks, or visit one of many fast food restaurants within a short drive of the training center.

AWARDS

High in Trial Rosette - High in Trial Eligibility: Competitors must be entered in all the Classes offered at the trial (either Element Classes or Games Classes) and qualify in all but one and must be entered in a minimum of 4 Classes (Element Classes or Games Classes) at a given Level to be eligible for a HiT award at that Level. All Classes (Element Classes and Games Classes) offered at a Classic or Variable Trial count towards HIT awards.

For Novice, there will be one Novice High in Trial award
(there is no breakdown between Novice A and Novice B).

Detection Dog Classic Title Rosette (passing all 4 elements at this trial)

1st through 4th place ribbons for each search element will be awarded, for
Novice A, Novice B, and Intermediate.

Qualifying ribbons for each search will be awarded.
