#### **Important Times:**

Check-in time is 8:30 | Briefing time is 9:00 | First dog on the line at 9:15AM Volunteer dogs will run first. Depending on entries and weather, we may start at 10.

#### AWARDS

- Qualifying ribbons will be available, self serve, at the end of your runs.
- High in Trial Awards:
  - High in Trial rosette (1st 4th) will be awarded for each level of competition.
  - High Rescue in Trial rosette will be awarded for the entire trial
  - High Champion of record rosette will be awarded for the entire trial
  - Dogs must be entered in all classes offered and have no more than one non qualifying score to be eligible for any HIT awards
  - Dogs must be registered with USCSS as a Champion and/or Rescue to be eligible for those awards.

#### HIGH IN TRIAL AWARDS ARE NOT BEING AWARDED FOR 125 RUNS, or fewer, THIS MUST BE NOTED IN THE PREMIUM.

\* High in Trial placements may be announced via Facebook, depending on time, with ribbons Available to be picked up at a later time/trial. *Ribbons will not be mailed*.

## NOTE ABOUT COLLARS AND LEASHES

No choke chains, prong collars or halti/head collars are permitted during searches. Collars may have tags. Leashes of any length (including Flexis) may be used while the dog is actively participating in search, but they must be switched over to a 6' (maximum) length leash when outside of the search area. Good sportsmanship towards all humans and all animals is expected at all times.

## <u>LUNCH</u>

We don't typically take an official lunch break, but may take a short break at the Judge's discretion. There will be NO potluck but there are many food places nearby (fast food, also restaurants, pizza, and food stores).

#### **VOLUNTEERS**

Every Trial relies on great volunteers to run smoothly and efficiently. Please sign up to volunteer at this trial if you can. Please email Jen (<u>jen@paws4dogtrial.com</u>) if you would be willing/able to help.

Dogs must have valid USCSS<sup>™</sup> registration numbers to compete in this trial. You can and should (whenever possible) register online and follow the payment instructions noted on the confirmation, we greatly prefer checks made out to Tova Training; mailed to Tova Training, % Barb Burri, 8 Ridgewood Rd., Plaistow, NH 03865.

## Steps for Joining USCSS<sup>™</sup>, Registering Dog and Entering this Trial:

1. All competitors must become a member of USCSS<sup>™</sup>, which is free. Competitors may join here: <u>http://members.uscaninescentsports.com/signup</u>.

3. When logged into their account on the USCSS<sup>™</sup> website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button. Or, enter via the "Enter This Trial" option for the trial, on the <u>Upcoming USCSS Events</u> page on the website.

4. Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.

- ★ The FLO box would be checked if you are looking to earn legs that count towards titles, but are not looking to earn placements or High In Trial Awards.
- ★ The FEO box is typically checked off only for a second dog entering the same class as another dog.
- ★ Leave both boxes unchecked to earn legs and be eligible for placements and High in Trial Awards.

5. Competitors will then receive an automated confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not USCSS<sup>™</sup>. The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.
