- For cancellation of entries on or before 5pm September 26, 2020 – Full refund minus \$25 processing fee.
- For cancellation of entries after 5pm September 26, 2020: 50% refund will be issued if host can fill your space.

- No refunds will be issued for cancellations during the last 72 hours before the event or no-shows.
