Registration Entry and Closing:

- Entries will be awarded in order of receipt.
- When payment is received by the host, you will receive an e-mail confirmation from Living with Dogs and information about volunteering and lunch.
- All dogs must have valid USCSS registration numbers to compete in this trial.
- All handlers must be members of USCSS to compete in this trial.
- Handlers may run multiple dogs, but titling dog must be run first.
- Nested searches will be used for various levels in this trial.
- No refunds will be made for withdrawal after April 25; prior to that date a \$25 processing fee will be withheld.
- No refund will be made if the team is absent, disqualified or excused by a judge for any reason.
