**\*COVID Precautions:** Due to the current covid numbers, and because of camp policy, **masks will be required when in the building** and when not socially distant. The Brainy Canine will be following regulations in place at trial time. Note there may be very short notice of changes to COVID requirements.

## **Steps for Joining USCSS™, Registering Dog and Entering this Trial:**

1. All competitors must become a member of USCSS™ (which is free). Competitors may join here: <http://members.uscaninescentsports.com/signup>
2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee.
3. When logged into their account on the USCSS™ website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button.
4. Competitors may then select which dog they are entering and select which classes and/or games they are entering.
5. Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host (The Brainy Canine/Nancy Almann), not USCSS™.
6. The confirmation email will include information on where to send your check. We are only accepting checks as payment. Competitors should note that their spot in the trial will only be held once payment is received.

Each dog must have a valid USCSS™ registration number to compete in this trial.

Handler may, space permitting, run multiple dogs; dogs competing for titles must run first; For Exhibition Only (FEO) dogs run afterwards.

**Parking:** Please follow direction from Parking Lot volunteer. There is plenty of space for parking, but there may be sight line issues depending on the level.

**Trial Venue Information:** We will be using the Brooktondale Nazarene Church camp. Please be respectful of their property. You must clean up after your dog and keep your dog leashed while you are on the camp's grounds. As per the rules set out by camp management, **failure to do so will trigger your immediate dismissal from the trial and the site. This includes dogs that are on dropped leashes.**

**There is NO SMOKING or VAPING allowed on premises.**

**Leash and Collars:** All dogs must be on a short leash and under control while on trial grounds except while showing. Flexi/retractable leads are not permitted on USCSS™ sanctioned trial grounds. No choke chains, prong collars or halti/head collars are permitted at Brainy Canine events. Leashes of any length may be used while the dog is participating in a run during a Class, but they must be switched over to a 6' length leash when outside of the search area.

The trial will be held indoors and outdoors. Surfaces used for search will be concrete, black top, dirt, grass, and gravel. There may be long walks to some of the search areas.

**Cancellation Policy:** No refunds are allowed for withdrawal from the trial after May 20, 2022 at 5 P.M. except in case of injured dog(s) (Veterinary note required).

Prior to May 20, 2022 at 5 P.M., refunds will be given if the spot in the class(es) entered can be filled from the wait list. The refund will be the entry fee(s) paid less a \$20 processing fee per trial day for those seeking a refund prior to that date.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.

Every attempt will be made to hold this event as scheduled. In the event of an "Act of God" such as flood, fire or civil disturbances, or any other causes beyond the control of the organizing committee, the event may be cancelled. We will make every attempt to contact entrants and inform them if the trial is cancelled.

**Volunteers:** Every trial relies on Great Volunteers to run smoothly & efficiently. You can run your dog(s) and volunteer at these trials. We are looking for a number of volunteers at each level so no one has to volunteer all day.
